apply. This rule is true even if the management and control is performed by a local nominee on behalf of an offshore owner. Isle of Man Exempt Corporation - Offshore Banking Income over £19,800 is subject to 20% tax, but there's a cap of at most £120,000 tax paid per year. The Isle of Man does not tax capital gains, wealth, and inheritance. There is no stamp duty. EU and EEA citizens can relocate to the Isle of Man and take up work freely.
